

Pappas Real Estate Development Program 2024 YEAR IN REVIEW

The Pappas Program has experienced a transformative year, propelled by the leadership contribution from Peter Pappas and his family. The program's strategic plan, developed over the past two years, has guided significant advancements across its three core areas: academics, research, and engagement.

The program is now under the umbrella of the Provost Office and our base of operations relocated to Centennial Campus, a move that underscores the program's interdisciplinary and entrepreneurial spirit. The program's official designation as an Academic Organization at NC State, marked by the addition of the RED prefix to courses, further solidifies its academic standing.

The program's commitment to fostering interdisciplinary collaborations has yielded promising results. Partnerships with various colleges have led to the initiation of new sponsored research projects, multi-college engagement initiatives, and formal academic collaborations.

Thanks to the tireless efforts of the Program's Director and Advancement team, fundraising efforts have gained significant momentum following the announcement of the naming endowment contribution. The program is aiming high, with a \$30 million endowment goal, and is already approaching the halfway mark towards this ambitious target.

Urban Plan Seminar | Spring 24'

The Urban Plan seminar is a project-based learning curriculum that requires students to form teams, reconcile competing agendas and create well-designed, market-responsive, and sustainable projects. Student teams present their proposal to a mock City Council that awards the development contract to the winning team.

Urban Plan was one of the most impactful classes I've taken in college because it gave me exposure to the full scope of a planning project, from public engagement and financing to design and "City Council" presentations. Working through the iterations of a real-life planning simulation with constant feedback from guest speakers across the field gave me an invaluable understanding of how all of the elements of the process work together. I ended Urban Plan with a much better understanding and respect for how different stakeholders have to come together and find compromises to make any given project a success.

Principles of Real Estate Development | Fall 24'

The Principles of Real Estate is a fundamental class for all students. This course offers a behind-the-scenes look at the increasingly complex process of real estate development. We explore the challenges and rewards of turning land into something meaningful – whether it's a bustling commercial center, a vibrant residential neighborhood, or a unique mixed-use development. Our students learn to analyze markets, evaluate feasibility, navigate regulations, and understand the critical role of community engagement.

This fueled my curiosity, pushing me to understand the intricate network of professionals who transform concepts into tangible buildings. 


Roll-out of Certificates


Pfizer Sanford Landscape Study



In response, the Program's study team conducted 3 sub-studies including a landscape management assessment, a biodiversity assessment, and an ecosystem service assessment of the property in the summer and fall of 2023.

Biltmore Park West

The Pappas Program and Biltmore Farms LLC undertook a real estate development ideation study that posits concepts for a novel, mixed-use real estate development on a 1000-acre parcel of land just outside of Asheville, NC.

Biltmore envisioned an environmentally sensitive development, which celebrates placemaking and community building, and supports a strong working class, as the site serves as a unique opportunity to replace "missing middle" rungs on the prosperity ladder.








Our study sponsors gave the team an opportunity to travel to Boston to visit the home and office of Frederick Law Olmsted.

Town of Spencer: Our study team assisted the Town of Spencer in developing a vision for a connected and meaningful public experience that honors the town's history while embracing its future.


NC State <> NC A&T CORE Partnership
